ORDER:

In the Government Order first read above, the Government have appointed State Commissioner for Differently Abled as “State Commissioner for Differently Abled Persons with Disabilities” as per sub-section (1) of Section 79 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016). In the Government Order second read above, orders were issued changing the nomenclature of the State Commissioner for Differently Abled as “Commissioner for Welfare of the Differently Abled”.

2. In accordance with the orders issued in Government Order second read above, the Government have decided to issue an amendment to the Government order first read above substituting the expression “State Commissioner for the Differently Abled” as “Commissioner for Welfare of the Differently Abled”. Accordingly, the appended Notification will be published in the Tamil Nadu Government Gazette.
