From the State Commissioner for Differently Abled Letter No.871/Government Rehabilitation Home-Admn.1/2016, dated 22.02.2016 and 15.02.2017.

ORDER:

In the letters read above, the State Commissioner for Differently Abled has stated that the Government Rehabilitation Home at Bargur, Krishnagiri District was started on 18.06.1972 and it is functioning in the Government premises. The building along with kitchen was constructed in the year 1972, at a cost of Rs.21 lakhs. As the building is more than forty years old and its kitchen is in highly dilapidated condition, construction of modern kitchen is very essential. He has, therefore, requested to accord administrative and financial sanction for the work of construction of Modern Kitchen for Government Rehabilitation Centre at Bargur in Krishnagiri District at an estimated cost of Rs.23.00 lakhs for the year 2016-2017.

2. After careful examination, the Government have decided to accept the proposal of the State Commissioner for Differently Abled and accord administrative and financial sanction for Rs.23.00 lakhs (Rupees twenty three lakhs only) for the construction of Modern Kitchen at Government Rehabilitation Home, Bargur, Krishnagiri District by invoking 'New Service' procedure.

3. The amount sanctioned in para 2 above, shall be debited under the following head of account:-

“4235 capital outlay on Social Security and Welfare-02 Social Welfare-101 Welfare of Handicapped – State’s Expenditure – JU Buildings – 16 Major Works”

4. This expenditure constitute an item of "New Service" and the approval of Legislative Assembly will be obtained in due course. Pending approval of the Legislature, the expenditure shall initially met by drawal of an advance from the Contingency Fund, the sanction of which will be done by Finance (BG-I) Department separately. The State Commissioner for the Differently Abled /Chief Engineer (Buildings), Chennai is requested to send the proposal in the prescribed format with a copy of Government Order to Finance (BG-I) Department for drawal of Contingency Fund advance. He is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2017-2018 to the Government (Finance (SW))/(BG-I) at the appropriate time without fail.

5. The State Commissioner for Differently Abled is authorized to incur the expenditure and requested to furnish the work completion certificate to the Government obtained from the Public Works Department after the completion of work.

6. This order issue with the concurrence of Finance Department, vide its U.O.No.45456/Fin(SW)/2017, dated 12.09.2017 and ASL No.1393 (one thousand three hundred and ninety three).
