ORDER:

In the Government Order first read above, orders were issued for continuance of the scheme of “Early Intervention Centre for children with visual impairment” in 7 districts for the year 2016-17 and sanction was accorded for a sum of Rs.21,98,000/-.

2. In the letter second read above, the State Commissioner for the Differently Abled has stated that the continuance of the scheme of ‘Early Intervention Centre for the Visually Impaired’ children has now proposed for 6 districts alone namely- Trichy, Coimbatore, Cuddalore, Vellore, Chennai and Tiruvannamalai, for the year 2017-18 and requested to accord sanction for a total amount of Rs.18,84,000/- .

3. After careful examination of the proposal of the State Commissioner for the Differently Abled, the Government permit the State Commissioner for the Differently Abled to continue the “Early Intervention Centre for the Visually Impaired children” in 6 districts during 2017-2018 as proposed and sanction is accorded for a total amount of Rs.18,84,000/- (Rupees Eighteen lakhs and eighty four thousand only) for the year 2017-18 as detailed in as follows:-

1.	Honorarium to Special Educators Rs.10,000/- x 12 months x 2 Special Educator	Rs.2,40,000/-
2.	Honorarium to One Ayah: Rs.1,000/- x 1 Ayah x 12 months	Rs.12,000/-
3.	Contingencies Rs.500/- x 12 months	Rs.6,000/-
4.	Rent Rs.3,000/- x 12 months	Rs.36,000/-
5.	Awareness, Identification, assessment and Guidance and Counseling	Rs.20,000/-
	Total	Rs.3,14,000/-

1.	Per centre	Rs.3,14,000/-
2.	For 6 Centres	Rs.18,84,000/-

(Rupees Eighteen lakhs and eighty four thousand only)

4. Further, the State Commissioner for the Differently Abled is permitted to decide on the selection and removal of the implementation of Non Governmental Organisations with the concurrence of Government. The State Commissioner for the Differently Abled shall draw and disburse the amount on quarterly basis through the District Differently Abled Welfare Officers.

5. The amount sanctioned in para 3 above shall be debited under the following head of account:-
