ORDER:

In the letter read above, the Engineer-in-Chief and Chief Engineer (General), Water Resources Department has sent a proposal for making payment of Arbitration fee to the Sole Arbitration in which he has stated that the Chief Engineer, Water Resources Department, Madurai Region, Madurai has furnished the proposal for payment of Arbitrator fee to the Sole Arbitrator Hon'ble Justice M.Vijayaragavan (Retd) for the Arbitration between Thiru G.Robert Sam and Superintending Engineer, Water Resources Department, Thambaraparani Basin Circle, Tirunelveli in connection with Rehabilitation of Thovalai Channel system tanks from L.S.0/000 Km to 38/400 Km in Thovalai Taluk of Kanyakumari District and requested to obtain necessary orders of the Government for the 50% of common expenses and Government share of Arbitration expenses of Rs.2,73,082/- against the total expenditure of Rs.5,46,165/- as detailed below:

- 2. The Engineer-in-Chief and Chief Engineer (General), Water Resources Department, Chennai has therefore requested to obtain necessary orders of the Government for the payment of 50% Government share for the common expenses and Government share of Arbitration expenses of Rs.2,73,082/- against the total expenditure of Rs.5,46,165/-.
- 3. The Government, after careful examination, have decided to accept the above proposal of the Engineer-in-Chief and Chief Engineer Resources Department, Chennai. (General), Water Accordingly, administrative sanction is accorded for the payment of 50% Government share towards Arbitration fee and other common expenses to the sole Arbitrator for Arbitration in O.P.No.273/2019 and A.F.No.178 of 2019 in connection with the work of Rehabilitation of Thovalai Channel System Tanks from 0/000 km to 38/400 km in Thovalai Taluk of Kanyakumari District for Rs.2,73,082/- (Rupees Two lakh seventy three thousand and eighty two only) against the total expenditure of Rs.5,46,165/- as mentioned in para 1 above.
