### **ORDER:**

In the G.O 1<sup>st</sup> read above, orders were issued to enhance the messing allowance to Associate National Cadet Corps Officers and Trainees from Rs.95/- to Rs.213/- per day / per head during Pre commission / Refresher Training Courses.

2. In the G.O 2<sup>nd</sup> read above, orders were issued to accord administrative sanction for a sum of Rs.7,08,000/- towards Messing Allowance in respect of Associate NCC Officers and Officer Cadets for Pre-Commission Training Course / Refresher Training Courses as the State Government share of 50% in the expenditure ratio of 50:50 between the State and Central Government from the year 2018-19.

3. In the letter 3<sup>rd</sup> read above, the Director General, NCC, New Delhi has requested the concerned State Directorate of NCC to obtain in principle approval from State Government to enhance Messing Allowance from Rs.213/- to Rs.410/- per head per day for Associate NCC Officers /Officer Cadets for attending Pre-Commission / Refresher Training Courses in the expenditure ratio share of 50: 50 between the State Government and Central Government.

4. Consequently, the Deputy Director General, National Cadet Corps in his letter 4<sup>th</sup> read above has informed that the Messing Allowance in respect of Associate NCC Officers / Officer Cadets for attending Pre-commission / Refresher Training Courses at OTA Kamptee / Gwalior / Air Force Station, Tambaram and Seamanship Kochi entitled for Rs.213/- per head per day (Messing Allowance of ANOs/ Officer Cadets attending Pre-Commission / Refresher Training Courses) be enhanced to Rs.410/- in the sharing ratio of 50 : 50 basis between the State Government and Central Government. The details of the expenditure will be as follows:

5. The DDG, NCC has, therefore, requested the Government to accord administrative sanction for a sum of Rs.11,82,000/-(Rupees Eleven Lakh Eighty Two Thousand only) towards the enhancement of Messing Allowance to the Associate NCC Officers / Officer Cadets from Rs.213/- to

Rs.410/- per head / per day for attending Pre Commission / Refresher Training courses.

6. The Government after careful consideration, accord administrative sanction for a sum of Rs.11,82,000/-(Rupees Eleven Lakh and Eighty Two Thousand only) towards the enhancement of Messing Allowance to the Associate NCC Officers / Officer Cadets from Rs.213/- to Rs.410/- per head / per day for attending Pre Commission / Refresher Training courses as the State Government share of 50% in the ratio of 50:50 basis between the State and Central Government.
