ORDER:

In the letter second read above, the Member Secretary, Sports Development Authority of Tamil Nadu has informed that Thiru.T.Mariyappan from Salem District had represented India in the Paralympics 2016 held in Rio De Janeiro from 7th to 18th September 2016 in High Jump and secured Gold Medal by leaping over a height of 1.89 meters.

2. He has stated that there is no provision to sanction High cash Incentive to the above Medal Winner for the above championship.

3. At this juncture, the Hon'ble Chief Minister of Tamil Nadu issued a press release on 10.09.2016 that a sum of Rs.2.00 Crores has been sanctioned to Thiru.T.Mariyappan for the achievement of securing Gold Medal in Paralympics on par with Olympics as a special case.

4. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction a sum of Rs.2,00,00,000/-(Rupees two crores only) as High Cash Incentive to Thiru.T.Mariyappan, who had won Gold Medal in High Jump in the Paralympics 2016 held in Rio De Janeiro, Brazil as a special case.

5. The Government after careful consideration, sanction a sum of Rs.2,00,00,000/-(Rupees two crores only) as High Cash Incentive to Thiru.T.Mariyappan who had won Gold Medal in High Jump in the Paralympics 2016 held at Rio De Janeiro, Brazil as a special case.

6. The expenditure sanctioned in para 5 above shall be debited under the following head of account:-

"2204-00 Sports and Youth Services – 104 Sports and Games -I. Non-Plan-AR Grants to Sports Development Authority of Tamil Nadu for Financial Assistance to Sportspersons – 09 Grants-in-Aid-01 Grants for Current Expenditure". (DPC 2204 00 104 AR 0917)

7. Necessary additional funds will be provided in Revised Budget Estimate/Revised Estimate/Final Modified Appropriation 2016-17. Pending provision of such funds, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 5 above. This expenditure should be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2016-2017. The Member Secretary, Sports Development Authority of Tamil Nadu is directed to include this expenditure sanctioned above, while sending the Budget proposal for Revised Budget Estimate / Revised Estimate / Final Modified Appropriation 2016-17 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2016-17 to Finance (BG-I) Department without fail.

8. The Member Secretary, Sports Development Authority of Tamil Nadu is directed to prepare the bill and present it to Pay and Accounts Office, Secretariat, Chennai through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The amount sanctioned above shall not be paid in cash but shall be credited into P.D. Account of the Sports Development Authority of Tamil Nadu, Chennai maintained by the Pay and Accounts Officer (North) under the following head of account:-

"K.Deposits and Advances (B) Deposits not bearing interest - 8443.00 Civil Deposits-800. Other Deposits-CH. Deposits of Tamil Nadu Sports Development Authority". (DPC 8443.00 800 CH 000D) by means of Cheque/Demand draft drawn in favour of PD Account No.6184513932.
