ORDER :

According to the Government of India's letter read above, permission of the prescribed authority is necessary, if the share of a member of the All India Service, in the cost of repairs to the property of a joint family, of which he is a member, out of the joint family funds, exceeds the prescribed limit of Rs.2000/-. The question whether similar provision need be incorporated in the Tamil Nadu Government Servants' Conduct Rules, 1973, has been considered by Government.

2. The Government have decided to make similar provisions in the Tamil Nadu Government Servants' Conduct Rules, 1973, with slight modifications. They, accordingly direct that if the Government Servant is a member of the Hindu Undivided Family and if the share of the repairs costing more than Rs.5000/- are made to the undivided property of the joint family out of the joint family fund, then he should intimate to the prescribed authority as and when such repairs are brought to his notice.

3. The following Notification will be published in the Tamil Nadu Government Gazette :-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Government Servants' Conduct Rules, 1973.

AMENDMENT

In the said Rules, in rule 7, in sub rule (1) after clause (b) the following clause shall be inserted, namely :-

"(c) Every Government Servant shall, if he is a member of the Hindu Undivided family and if the share of the Government Servant in the cost of repairs made to the undivided property of the joint family, out of the joint family funds exceeds Rs.5000/-, intimate the fact to the prescribed authority as and when such repairs are brought to his notice".
