ORDER:-

The Government have proposed to create a Counselling Centre in the Office of the Managing Director, TAHDCO to promote Adi Dravidar Entrepreneurs. The Members of the Counselling Centres are as follows:-

- i) General Manager - Project-O/o.TAHDCO
- ii) Joint Director – O/o Adi Dravidar Welfare
- iii) District Manager, Kancheepuram / Chennai.
- iv) District Adi Dravidar and Tribal Welfare Officer, Thiruvallur / Chennai

2) The functions of the Counselling Centre are as follows:-

- (i) The Members of the Counselling Centre will sit on all Mondays, hear the petitioners / visitors and give technical guidance wherever necessary.
- (ii) They can also invite any member from the Industry Associations or from Government departments / Government Undertakings to assist them for a thorough and full fledged guidance.
- (iii) They should also inform them of the opportunities available in TAHDCO and other departments.
- (iv) Availability of viable projects that can be taken up can be appraised in consultation with the department of Industries and Commerce.
- (v) A data should be created for the Entrepreneurs already identified, loans extended, projects taken up, success / failure of the project, has to be maintained by the Entrepreneur Cell.

- (vi) There should be a register maintained for making entries of all petitions received and disposed of.
- (vii) Availability of Financial Assistance Scheme like Prime Ministers Employment Generated Programme(PMEGP), Unemployment Youth Employment Generated Programme (UYEGP) (State), TAHDCO, TIIC, SIDCO, SIPCOT Schemes etc may be briefed and a booklet on all schemes available in the State should be prepared and kept for guidance.

3) The Managing Director, TAHDCO will peruse the register atleast once in a month, record his views and send his review to the Government on or before 5<sup>th</sup> of every month.
