1. From the Commissioner, Adi Dravidar Welfare, Letter No.T4/9439/2012, dated 15.11.2012.
2. From the General Manager, NABARD Letter Ref.No,NB(TN)SPD/260/RIDF-XVIII/2012-13, dated 31.12.2012

ORDER:-

In the letter first read above the Commissioner of Adi Dravidar Welfare has sent a proposal to construct 44 hostels including 5 KW Solar Power System and 12.5% administrative charges (41 in Plain and 3 in Hill area) estimated at the rate of Rs. 89.19 lakhs per hostel in Plain and Rs.99.42 lakhs per hostel in Hill area, as per the Public Works Department Schedule of rates.

2. The Government has then forwarded the above proposal to NABARD, after deducting the subsidy amount of Rs.81/- per watt (Rs.4.05 lakhs per hostel) from Government of India for provision of Solar Power System, for construction of 44 Numbers of 50 students hostel @ Rs.85.14 lakhs per hostel in plain area and @ Rs.95.37 lakhs per hostel in hill area and the total cost for construction of 44 hostels to the tune of Rs.3,777 lakhs (41XRs.85.14 lakhs +3X Rs.95.37 lakhs).

3. In the letter second read above, NABARD has sanctioned loan for a sum of Rs.2,836.96 lakhs with Total Fund Outlay as Rs.3,337.39 lakhs (excluding 12.5% administrative charges) for construction of 44 hostels.

4. In light of the sanction accorded by the NABARD the Government after careful examination accord administrative sanction for the Construction of 41 hostels in plain area and 3 hostels in hill area, listed in the Annexure to this order, at a cost of Rs.35.04 Crore @ Rs. 88.53 lakhs for construction of each hostel in hill area and @ Rs. 78.99 lakhs for construction of each hostel in plain area with the loan assistance of NABARD under Rural Infrastructure Development Fund-XVIII (RIDF-XVIII) as follows:-

5. The expenditure sanctioned in para 4 above shall be debited to the following new head of account opened under demand No.04-02:-

"4225 – Capital Outlay on welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes -01-Welfare of Scheduled Castes -277 – Education –Schemes of the Twelfth Five Year Plan-II State-Plan-JM-Construction of Hostels with Loan Assistance of NABARD -16 Major works. (DPC.4225 01 277 JM 1609)

The Director of Adi Dravidar Welfare is the Estimating, Reconciling and Controlling authority for the above new head of account. The Pay and Account Officer / Treasury Officer concerned are requested to open the above new sub-head of account in their books.

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of advance from the Contingency Fund will be issued by the Fin(BG-I) Dept. The Director, Adi Dravidar Welfare is directed to send application in the prescribed form along with the copy of his order to Fin (BG-I) Dept, for sanctioning the advance for required quantum. He is also directed to send necessary note for inclusion of the expenditure in the Supplementary Estimates to obtain approval of the Legislature at the appropriate stage.

7. The amount sanctioned in para 4 above shall not be paid in cash but shall be credited to the following head of account by means of an account payee cheque in favour of the Personal Deposits Account of TAHDCO.

8. The Director, Adi Dravidar Welfare in consultation with the Managing Director, TAHDCO shall chart out a time schedule for construction of hostels and send the date of commencement and completion of the hostels.

9. The Managing Director, TAHDCO is requested to move through TamilNadu Energy Development Agency to obtain the subsidy from Govt. of India @ Rs. 81 per watt (Rs.4.05 lakhs per hostel)for provision of solar power system to the hostels, in addition to the amount sanctioned in para 4 above. He is also further requested to ensure the quality of work is as per the standards and timely completion of work as per the Schedule and instructions issued by NABARD.

10. This order issues with the concurrence of Finance Department vide its U.O.No.12/JS(RMD)/13 dated 5.3.2013 and with ASL.No.2423 (Two Thousand Four Hundred and Twenty Three).
