**ORDER:-**

In the G.O. first read above, the Government had sanctioned a sum of Rs.10.00 lakhs (Rupees ten lakhs only) towards undertaking Socio-Economic and Educational status survey of Scheduled Tribes in Tamilnadu under Part.II scheme during the year 2010-11. Wherein, the Director of Tribal Welfare had been requested to entrust the above survey work to the Director, Tribal Research Centre.

2. In the letter second read above, the Director of Tribal Welfare has submitted proposals under the Part.II scheme 2011-12 for sanctioning a sum of Rs.10.00 lakhs so as to complete the survey work in all the districts.

3. The State Planning Commission has recommended the scheme of Socio-Economic Survey of Scheduled Tribes in Tamilnadu, on condition that the department should complete the Final Survey Report with in the financial year 2011-2012.

4. The Government after careful examination of the above proposals of the Director of Tribal Welfare, sanction a sum of Rs.10.00 lakhs (Rupees Ten lakhs only) to complete the work of Socio, Economic and Educational status survey of Tribals in Tamilnadu in the prescribed proformae annexured to this order.

5. The expenditure sanctioned in para 5 above shall be debited to the following Head of account:

"2225- Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes – 02 Welfare of Scheduled Tribes – 800 Other Expenditure – I Non Plan – AI – Socio Economic Survey of Tribals – 33 Payments for Professional and Special Services -09 –Other Payments – [DPC 2225-02-800-AI-3393]"

6. The Director of Tribal Welfare is authorized to draw and disburse the amount sanctioned in para 5 above to the Director of Tribal Research Centre to complete the above Survey work and is requested to make necessary arrangements for computerizing the data as and when the survey works are completed. The Director of Tribal Welfare is also requested to complete the survey work in all the districts of Tamilnadu and furnish the completion report within the financial year 2011-12. The expenditure has to be incurred only for the item sanctioned by the Standing Finance Committee. The unspent / excess amount if any has to be surrendered.

7. The Director, Tribal Research Centre is requested to undertake the Socio-Economic Survey of Scheduled Tribes by collecting data as per the prescribed proforma within the financial year 2011-12. He is also requested to handover the data to the Director of Tribal Welfare after completion of the survey work. The District-wise Utilization Certificate for the amount already sanctioned and the amount now sanctioned may be sent to the Director, of Tribal Welfare and he inturn furnish a consolidated Utilization Certificate to the Government at the end of this financial year.


