ORDER:-

The Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) is sanctioning Margin Money Assistance to various Individual Entrepreneurship Schemes for the benefit of Adi Dravidars from its share capital assistance received from the State and Central Governments on 51:49 basis respectively every year towards share capital investment in Tamil Nadu Adi Dravidar Housing and Development Corporation Limited.

2) In the reference first cited, the Government have sanctioned a sum of Rs.331.50 lakhs of State Share equity for the year 2000-2001 and the reference second cited, sanctioned Share equity an amount of Rs.663.00 lakhs for the year 2001 – 2002 and 2002-2003. From the year 2003-04 the share capital assistance had not been released by State and Central Government to the TAHDCO. In the reference fourth cited, Managing Director, TAHDCO has sent proposal to the Government for sanctioning and releasing the State's Share Capital Assistance to TAHDCO for the period from 2003-2004 to 2010-2011.

3) The State Government after careful consideration accord sanction and release a sum of Rs.13.26 Crores (Rupees Thirteen Crores and Twenty Six lakhs only) towards State Share Capital investment to TAHDCO for the years 2003-04 to 2006-07.

4) The Commissioner of Adi Dravidar Welfare, Chennai-5 is authorized to draw and disburse the Share Capital Assistance as sanctioned in para 3 above to the Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) immediately and send a report in this regard to the Government early.

5) The amount sanctioned above may be debited to the following Head of Account:-

"4225 - Capital Outlay on Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes - 01 - Welfare of Scheduled Castes - 190 Investment in Public Sector Undertakings and other corporations - Schemes in the Eleventh Five Year Plan - II State Plan - JE. 6) Necessary additional funds of Rs. 6.00 lakhs over and above the provisions made on BE 2011-2012 will be provided in RE/FMA 2011-2012, pending provision of such funds the Commissioner, Adi Dravidar Welfare is authorized to draw and disburse the amount sanctioned in para 3 above the Commissioner, Adi Dravidar Welfare is requested to include this item of expenditure while sending proposal for RE/FMA 2011-2012 without fail.

7) The amount sanctioned in para 3 above towards investment in Share Capital of Tamil Nadu Adi Dravidar Housing Development Corporation Ltd., for the year 2003-2004 to 2006-2007 should be deposited in Personal Deposit Account of TAHDCO Ltd., and released as Margin Money to Adi Dravidars as and when necessary duly maintaining the proper records with full details of beneficiaries with relevant registers. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) should send progress of details of funds released district wise every quarter without any delay.
