### ORDER:

Hon'ble Chief Minister made an announcement under Rule 110 of Tamil Nadu Legislative Assembly as below :-

2011-2012 ஆம் ஆண்டில் வனப்பணியாளர்களுக்கு மாதம்தோறும் வழங்கப்படும் இடர்படி காவல்துறை பணியாளர்களுக்கு இணையாக வழங்கப்பட்டது. 2013-14 ஆம் ஆண்டில் வனத்துறை பணியாளர்களுக்கு காவல்துறை பணியாளர்களுக்கு நிகராக, ரூ.2.13 கோடி செலவில் சீருடை வழங்குதல், சலவைப்படி மற்றும் இடர்படி ஆகியவற்றை உள்ளடக்கிய ஒருங்கிணைந்த திட்டம் ஒன்று செயல்படுத்தப்படும். இதன் மூலம் சுமார் 5600 வனப்பணியாளர்கள் பயனடைவார்கள்.

2. The Principal Chief Conservator of Forests in his letter read above has sent a proposal for grant of Cash Allowance in lieu of Uniform to the Forest Range Officer, Forester, Forest Guard and Forest Watcher. In respect of Forest Watcher and Forest Guard Rs.2,650/- and for Forester and Forest Range Officer Rs.2800/- has been proposed in lieu of uniform per year. He has also proposed @ Rs.350/- as Washing allowance to the Forest Personnel. Apart from this, he has proposed risk allowance @ Rs.400/- per month for Forest Watcher to Forest Range Officer and @ Rs.450/- per month for Assistant Conservator of Forests and State Deputy Conservator of Forests. He has furnished the financial implication for the above items as detailed below :-

3. The Government after careful examination accept the proposal of the Principal Chief Conservator of Forests and accord sanction of an amount of Rs.399.62 lakhs (Rupees Three crore ninety nine lakhs and sixty two thousands only) towards enhancement in grant of Cash Allowance in lieu of supply of Uniform, Washing allowance and Risk allowance to the personnel of Forest Department on par with the personnel of Police Department for the year 2013 – 2014 as mentioned at para 2 above.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account :-

2406 – Forestry and Wildlife – 01 Forestry 001 – Direction and Administration – I Non-plan – AB – District Establishment 01.  
Salaries – 04 other allowances. (DPC: 2406 01 001 AB 0145)

5. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriation 2013-14. Pending provision of such funds, the Principal Chief Conservator of Forests, Chennai-15 is authorized to draw and disburse the amount sanctioned in para-3 above. The Principal Chief Conservator of Forests, Chennai-15 is requested to include this expenditure while sending budget proposal for Revised Estimate / Final Modified Appropriation 2013-14 to Finance Department without fail.

6. This order issues with the concurrence of Finance Department vide its U.O. No.59300/AHD&F/2013-1, dated 23.10.2013 and with ASL No.1749 (one thousand seven hundred and forty nine).
