### ORDER:-

While moving the Demand in the Budget Session, Hon'ble Minister (Forests) has made the following announcement in the Tamil Nadu Legislative Assembly:-

“பார்வையாளர்களிடையே வனம் மற்றும் வன உயிரினங்கள் குறித்த விழிப்புணர்வினை அதிகரிக்க மாண்புமிகு தமிழக முதலமைச்சர் இதயதெய்வம் புரட்சித் தலைவி அம்மா அவர்களின் ஆணைப்படி 2013-14 ஆம் ஆண்டில் ரூ.0.20 கோடி செலவில் வண்டலூர் அறிஞர் அண்ணா உயிரியல் பூங்காவில், பதப்படுத்தப்பட்ட தாவரங்கள், மற்றும் பூச்சிகள், வரலாற்று புகைப்படங்கள், மண் அருங்காட்சியகம் மற்றும் வன உயிரின கலைப்பொருட்கள் உள்ளடங்கிய ஒரு வனம் மற்றும் வன உயிரின அருங்காட்சியகம் ஏற்படுத்தப்படும். இந்த அருங்காட்சியகம் அறிவியல், கலை, கலாச்சாரம் மற்றும்

வரலாற்று முக்கியத்துவம் வாய்ந்த பொருட்களின் சேகரிப்பு கூடமாக ஏற்படுத்தப்பட்டு, பொது மக்கள் பார்வைக்கு அனுமதிக்கப்படும்.”

2. Based on the above announcement, the Principal Chief Conservator of Forests has sent a proposal for “Establishment of forest and Wildlife Museum” at a cost of Rs. 20.00 lakhs at Arignar Anna Zoological Park, Vandalur, Chennai as detailed below:-

3. The Principal Chief Conservator of Forests has therefore requested the Government to sanction a sum of Rs. 20.00 lakhs for establishment of Forests and Wildlife Museum at Arignar Anna Zoological Park, Vandalur Chennai.

4. The Government after careful consideration accept the proposal of the Principal Chief Conservator of Forests and accord to sanction a sum of Rs. 20.00 lakhs (Rupees Twenty lakhs only) for establishment of Forests and Wildlife Museum at Arignar Anna Zoological Park, Vandalur, Chennai.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:

“4406 – Capital Outlay on Forestry and Wildlife- 02 Environmental Forestry and Wildlife – 111 Zoological Park - Scheme in the Twelfth Five Year Plan – II State Plan JI – Establishment of Advanced Institute for Wildlife Conservation - 16 - Major Works”.

6. The expenditure sanctioned in para-4 above is an item of “New Instrument Service” and the approval of the Legislature will be obtained in due course. Pending approval of Legislature, the expenditure will be initially met from the Contingency Fund. The Principal Chief Conservator of Forests and Chief Wildlife Warden shall apply for the sanction of Contingency Fund advance to Finance [BG-I] Department, in the

prescribed format along with the copy of this order. The Principal Chief Conservator of Forests and Chief Wildlife Warden is also requested to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2013-14 at the appropriate time.
