**ORDER: -**

The following amendment is issued to para 4 of the Government Order fourth read above.

**Amendment**

Para 4 of the Government Order fourth read above shall be substituted with the following para.

4) Accordingly, the Government hereby revise the eligibility of travel in different classes by rail/air as follows:

| <b>Grades</b>  | <b>Eligibility</b>  |

| <b><u>Grade -I</u></b><br><br>(a) Employees with basic pay of Rs.15,000/- or more (including officers of All India Services) serving in the State. | Air or Air-conditioned First Class by Rail irrespective of whether the journey is within or outside the State.                          |
| (b) Employees with a basic pay of Rs.10,000/- or more (including officers of All India Services) serving in the State.                             | (i) Air Journey outside the State<br>(ii) First class or Air- conditioned Second Class by rail for journey within or outside the State. |

| <b>Grade -II</b> (Employees drawing a basic pay of Rs.5,500 and above but below Rs.10,000) | First Class by Rail   |
| <b>Grade - III and Grade IV</b>  | Second Class by Rail. |

Government also direct that the employees drawing a basic pay of Rs.16, 000/- and above alone shall be permitted to perform air travel on Leave Travel Concession purposes as ordered in the Government Order second read above.
