After careful examination, the Government has decided to implement the recommendations made by the Pay Grievance Redressal Cell in respect of Rehabilitation / Welfare of Differently Abled Persons Departments. Accordingly, Government direct that the scales of pay of the following posts shall be revised as shown below:--
