G.O. Ms. No. 235, Finance (Pay Cell) Department, dated: 1—6—2009

I am to invite your attention to the references cited.

2. In para 2 (vi) of the Government Order cited, it has been ordered that in the case of pensioners/family pensioners to whom pension/family pension has to be revised beneficial to them at 50% / 30% of the minimum of the Pay Band + Grade Pay applicable to the post as on 1—1—2006 such of the Pensioners / Family Pensioners shall have to apply to the Pension sanctioning authorities through the Department they last served and the authorities concerned shall revise both the Pension/Family Pension.

3. The Deputy Accountant General (Pension) in the reference second cited has pointed out that though it has clearly been stated in para—9 of the Government Order cited that the authority who is competent to process and forward the pension proposals to the Accountant General has to revise the Pension / Family Pension and in such type of cases, most of the departmental officers are forwarding the applications received from the pensioners / family pensioners to his office for such revision assuming Accountant General as the pension sanctioning authority. He has therefore requested to issue necessary instruction in this regard to the departmental officers.

4. In this connection, I am directed to state that in the case of pensioners/ family pensioners to whom pension/family pension has to be revised with reference to para 2(vi) of the Government Order cited, at 50% / 30% of the minimum of the pay band plus grade pay applicable to the post as on 1—1—2006, such of pensioners/family pensioners shall apply to the department last served by the employee concerned. After revising the pension/family pension of the retired employees, the departmental officers shall forward such applications directly to Pension Disbursing Officers viz., Pension Payment Officer / Treasury Officers / Sub – Treasury Officers as the case may be and not to the Office of the Accountant General.
