Act – Tamil Nadu Transparency In Tenders Act 1998 (Tamil Nadu Act 43 of 1998) – Notification under section 16(f) of the Act – Procurement of services of Training from State Government and Government of India Educational and Training Institutes including the Universities established by State and Central Government – Notified.

ORDER:

The procurement of services of training by the Government Departments and other procuring entities under the Tamil Nadu Transparency In Tenders Act, 1998 on most of the occasions is needed to be placed directly with State Government and Government of India training and Educational Institutes and with Universities established by the State Government or Central Government. As the fee is fixed as prescribed by the respective institute or University and as these institutes do not participate in competitive tender, the selection of these service providers for training becomes difficult. Hence the procurement of quality training services from State Government and Government of India Educational and training Institutes and with State and Central Universities needs to be notified under section 16(f) of the Act.

The Government after careful consideration have decided to issue a notification under clause (f) of section 16 of the Tamil Nadu Transparency in Tenders Act, 1998 (Tamil Nadu Act 43 of 1998) permitting procurement of services relating to training by the Government and other procuring entities under the said Act from the State Government and the Government of India Educational and Training Institutes and the Universities established by the State and Central Government .

3. Accordingly, the following Notification will be published in Tamil Nadu Government Gazette Extraordinary dated the 7th October 2008.

NOTIFICATION

Under clause (f) of section 16 of the Tamil Nadu Transparency in Tenders Act, 1998 (Tamil Nadu Act 43 of 1998), the Governor of Tamil Nadu hereby notifies the procurement of services of training by Government Departments and other procuring entities under the said Act from the State Government and the Government of India Educational and Training Institutes and the Universities established by the State and Central Government.
