I am to invite your attention to the references cited.

2) Representations have been received by the Government from certain pensioners seeking permission to revise their option consequent on the issue of clarification in the reference third cited in regard to commutation of additional pension, subsequent to issue of the Government Order second cited.

3) I am to state that in the case of pensioners retired between 1.1.2006 to 31.5.2009 and who have not opted earlier for commutation of additional pension due to revision of pension as per the orders issued in the Government Order second cited may now be allowed to exercise their revised option for commutation of additional pension consequent on the issue of clarification by the Government in the Government letter third cited and the commutation value revised accordingly.

4) I am also to state that such revised option should be exercised within 3 months from the date of issue of this clarification.
