ORDER:

In the Government Order first read above, orders have been issued constituting an Official Committee under the Chairmanship of Principal Secretary to Government, Home Department with the Principal Secretaries to Government, Finance, Personnel and Administrative Reforms and School Education Departments as its Members to examine and make necessary recommendations for the implementation of the revision of scales of pay and allowances of State Government Employees, Teachers including employees of Local Bodies and also revision of Pension / Family Pension, Retirement benefits etc. based on the decisions of the Central Government on the recommendations of the Sixth Central Pay Commission and submit its report to Government within three months. The tenure of the Official Committee has been extended for a further period of three months beyond 18—2—2009 to finalise the report.

2) In the Government Order third read above, orders have been issued among others extending the interim arrears to employees governed by University Grants Commission / All India Council for Technical Education scales of pay also. The Government of India has also issued orders revising the scales of pay of University Grants Commission employees. Hence, Government has now decided to refer the issue relating to revision of scales of pay of employees governed by University Grants Commission / All India Council for Technical Education scales of pay to the Official Committee for its detailed examination and necessary recommendations.
