**PENSION - Dearness Allowance to the pensioners and family pensioners - Revised rate admissible from 1st July, 2000 - Orders - Issued.**

**ORDER:**

In the Government Order first read above, orders were issued sanctioning the revised rate of dearness allowance in the revised pension/family pension to the State Government pensioners/family pensioners as detailed below.

Date from which payable	Revised rate of Dearness Allowance(per month)
With effect from 1st January, 2000	38% of pension / family pension

In the said Government Order, orders were also issued sanctioning revised rate of dearness allowance at 30% with effect from 1st January, 2000 in the revised ex-gratia amount to the widows and children of the deceased Contributory Provident Fund / Non-pensionable establishment beneficiaries of State Government and the former District Board.

2. The Government of India have now sanctioned revised rate of dearness relief to their pensioners / family pensioners with effect from 1st July, 2000 as follows:-

Date from which payable	Revised rate of Dearness Allowance (per month)
1 st July, 2000	41% of pension / family pension

The Government of India have also sanctioned revised rate of dearness relief at 33% with effect from 1st July, 2000 to the widows and children of the deceased Contributory Provident Fund beneficiaries of Central Government who are drawing ex-gratia amount of Rs.605/- per month.

3. Consequent on the orders issued by the Government of India in their Office Memorandum second read above, the Government now sanction the revised rate of dearness allowance in the revised pension / family pension to the State Government pensioners / family pensioners as indicated below:-

Date from which payable	Revised rate of Dearness Allowance(per month)
1st July, 2000	41% of pension / family pension

The Government also sanction revised rate of dearness allowance at 33% with effect from 1st July, 2000 in the revised ex-gratia amount to the widows and children of the deceased Contributory Provident Fund / Non-pensionable establishment beneficiaries of State Government and the former District Board.

4. The State Government employees who had drawn lumpsum payment on absorption in Public Sector Undertaking / Autonomous body / Local body / Co-operative Institution and have become entitled to restoration of 1/3rd commuted portion of pension as well as revision of the restored amount will also be entitled to the payment of dearness allowance at 41% on the restored amount of 1/3rd commuted portion of pension with effect from 1st July,2000.

5. The Government have decided that the increase in dearness allowance shall be paid in cash to the above categories. The amount of dearness allowance involving a fraction of a rupee shall be rounded off to the next higher rupee. It will be the responsibility of the Pension Disbursing Authority including Public Sector Banks etc. to calculate the quantum of dearness allowance payable in each individual case.

6. Pending formal authorisation by the Accountant General, the dearness allowance shall be paid straightaway by the Pension Pay Officer, Chennai-6, Treasury Officers and Public Sector Banks concerned.

7. This order will apply to the following categories of pensioners:-

- i) Government pensioners, Teacher pensioners of aided and local body educational Institutions and other pensioners of local bodies.
- ii) Present and future family pensioners; In the case of divisible family pensioners, dearness allowance shall be divided proportionately;
- iii) Former Travancore-Cochin State pensioners drawing their pension on 1st November, 1956 in the Treasuries situated in the areas transferred to Tamil Nadu State on that date, ie., Kanniyakumari District and Shencottah taluk of Tirunelveli District.
- iv) Pensioners drawing their pension on 1st April, 1960, in the Tiruttani Sub- Treasury in whose cases pensions were sanctioned by the Composite Madras State prior to 1st October, 1953 or by the Andhra Pradesh State prior to 1st April, 1960.

- v) Pensioners of the Ex-Governor's Head Establishment in receipt of 'Mustering out' pension;
- vi) Pensioners who are in receipt of special pensions under Extra-ordinary Pension Rules, Tamil Nadu and Compassionate Allowance;  
Ex-Pudukkottai pensioners.

Surrendered and thrown out Teachers in the transferred areas of Kanniyakumari district and Shencottah taluk of Tirunelveli district.

8. The expenditure of dearness allowance payable to the pensioners shall be debited to "2071. Pensions and Other Retirement Benefits - 01.Civil - 101. Superannuation and Retirement Allowance - I Non-Plan-AC. Dearness Allowance to Pensioners- 03. Dearness Allowance (D.P.Code 2071.01.101.AC.0306) and the dearness allowance payable to the family pensioners shall be debited to "2071.Pensions and Other Retirement Benefits -01.Civil-105.Family Pension - I.Non-Plan-AC. Dearness Allowance to Family Pensioners of Tamil Nadu Government - 03 Dearness Allowance (D.P.Code 2071 01 105 AC 0308). The expenditure on dearness allowance to those who are in receipt of ex-gratia payment of Rs.605/- per month shall be debited to "2071. Pensions and other Retirement Benefits - 01.Civil - 800. Other Expenditure - I.Non-plan-AH. Ex-gratia payment to families of deceased Contributory Provident Fund/Non-pensionable

establishment beneficiaries -27.Pensions - 09. Others. (DP Code 2071 01 800 AH 2795)".

9. The increased expenditure due to the sanction of dearness allowance in this order is allocable among the successor States as per the provisions laid down under the State Reorganisation Act, 1956.
