ORDER:

In the G.O. read above Government ordered enhancement of Festival Advance to Government employees from Rs.750/- to Rs.1,000/- with effect from 13.12.1995 payable on the occasion of festival once in a calendar year.

2. Based on the announcement made in the Budget Speech 2007-2008, Government direct that the Festival Advance be enhanced from Rs.1,000/- to Rs.2,000/- (Rupees Two Thousand only). There shall be no change in the existing procedure for sanction and recovery of the advance.

3. These orders shall apply to the teaching and non-teaching staff of the local bodies and aided educational institutions.

4. These orders shall take immediate effect and apply to festivals after this date.
