ABSTRACT

MEDICAL AID - Government Employees Health Fund Rules 1991 -
Extension of the scheme to dependant family members and
enhancement of quantum of assistance - Orders issued.

ORDER:

In the Government Order read above, orders have been issued constituting "Government Employees Health Fund" so as to provide financial assistance to Government employees undergoing special surgeries/treatment. Accordingly, rules have been framed for the purpose of granting financial assistance to Government employees to undergo advanced surgery/treatment. These rules are applicable to all categories of full time regular (Time-Scale) Government employees of the Government of Tamil Nadu.

2. According to these rules, a grant to the maximum extent of Rs.25,000/- or total assistance required whichever is lower is being sanctioned in the case of treatment in India and a loan to the extent to which it exceeds Rs. 25,000/- is sanctioned carrying simple interest at 10% in the case of treatment in Countries other than India.

3. Government have considered the need for enhancing the quantum of assistance under the scheme in view of the increased cost of medical treatment in private hospitals. Representations have also been made to Government for extension of the facility under the scheme to dependant family members as well as to officers of All India Services serving in the State.

4. The Government after careful consideration pass the following orders:

- i) the maximum grant of Rs.25,000/- fixed in the G.O. read above be increased to Rs.50,000/- or 75% of the actual cost of the specialised

advanced surgery/treatment as referred to in the schedule I of the G.O. read above, whichever is lower;

- ii) the benefit under the scheme be extended to family members of Government employees specified in rule 2 of the Tamil Nadu Government Employees Health Fund Rules 1991 ; and
- iii) the assistance under the scheme be extended to the Officers of All India Services serving in the State and to their family members.

5. There shall be no change in the existing rules and conditions except the amendments to the rules administering the scheme appended to this order.

6. These orders shall take effect from the date of issue.



ANNEXURE

AMENDMENTS TO TAMIL NADU GOVERNMENT EMPLOYEES
HEALTH FUND RULES, 1991.

AMENDMENT - I

Substitute the following for the existing Rule 2:-

2. Extent of Application:

These rules shall extend to the whole of the State of Tamil Nadu. These rules shall apply to all categories of full time regular (Time-Scale) Government Employees of the Government of Tamil Nadu and their family members and to All India Service Officers serving in the State and to their family members.


"Family" for the purpose of this scheme will include, 'Wife and Children' of the Government servant. In case of female Government servant 'Husband and Children' and in the case of unmarried Government servant the dependant parents.

AMENDMENT - II

Substitute the following for the existing Rule 6 (c):

- c) Assistance sanctioned under these rules shall be in the form of ----
- i) grant to the maximum extent of Rs.50,000/- or 75% of the actual cost whichever is less, in the case of treatment in India.
 - ii) loan to the extent to which exceeds Rs.50,000/- shall carry simple interest at 10% in the case of treatment in countries other than India.
