2) The Secretary, Tamil Nadu Public Service Commission in the reference fourth read above has requested the Government to revise the scale of pay of the Members of the Tamil Nadu Public Service Commission from Rs.63,850/- ( Fixed Pay ) to Rs.67000—79000 on par with HAG Officers of All India Service citing the orders issued by Government of India in the reference second read above.

3) After careful consideration, Government has decided to revise the Fixed Pay of Members of Tamil Nadu Public Service Commission on the analogy of the earlier revision ordered in the Government Order first read above. Accordingly, Government direct that the Fixed Pay of the Members of the Tamil Nadu Public Service Commission shall be revised from Rs.63,850/- p.m. to Rs.67,000/- p.m. (i.e. the minimum of the HAG scale of pay of Indian Administrative Service viz., Rs.67000—79000).


