
In the Government Order cited, among others, orders were issued to the effect that the arrears due for the period from 1—1—2007 to 31—8--2009 after adjusting the interim Arrears shall be paid in three equal annual instalments viz., first instalment in the year 2009 –10, second instalment in the year 2010 –11 and third and final instalment in the year 2011–12. Accordingly, first instalment of arrears has already been released in the year 2009 –10 and second instalment of arrears is due in the year 2010 –11.
