#### **ORDER:**

In the Government Order first read above, orders were issued for the constitution of Medical Services Recruitment Board exclusively for Health and Family Welfare Department for filling up of the vacancies existing in the Medical Department, which includes Medical College Hospitals, Government District and Taluk Headquarters Hospitals, Non Taluk Hospitals, Government Primary Health Centres and State Health Transport Department etc.

2. The Chairman, Medical Services Recruitment Board has stated that a legal cell for the Medical Services Recruitment Board is essentially required for the Board and he has requested the Government to create the legal cell with the following post for Medical Services Recruitment Board.

1)	Legal Officer in the cadre of Under Secretary to Government, Law Department	One post	On Deputation from Government
2)	Assistant with computer knowledge	One post	Deputation (or) outsourcing
3)	Office Assistant	One post	Deputation (or) outsourcing



3. The Government after careful examination, accord sanction for creation of a separate legal cell for the Medical Services Recruitment Board with the following staff and Recurring expenditure of Rs.10.95 lakhs per annum.

- (1) Legal officer - 1 post (on deputation from Government, Law Department in the cadre of Under Secretary)
- (2) Assistant with computer knowledge - 1 post (on deputation/outsourcing)

4. The expenditure towards Pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-

"2210 - Medical and Public Health - 01 - Urban Health Services - Allopathy - 001 Direction and Administration - I Non Plan AI - Medical Services Recruitment Board - 01 Salaries"

5. Necessary funds will be provided in the R.E/FMA 2013-14. Pending provision of funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned in para 3 above. The Director of Medical and Rural Health Services is requested to include this expenditure while sending the budget proposals for R.E / F.M.A 2013-14 to Government in Finance department without fail.
