ORDER:

In the Government order first read above, the Government have accorded Administrative and Financial sanction for a sum of Rs. 6,00,44,000/- towards construction of second floor over the existing first floor of the new multi storied building in Tamil Nadu Government Dental College and Hospital, Chennai.

2. The Director of Medical Education has forwarded the Revised Administrative Sanction proposal for a sum of Rs. 6,37,93,334/- received from the Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai towards Construction of second floor over the existing first floor of the New Multi Storied Building in Tamil Nadu Government Dental college and Hospital, Chennai along with the Revised estimate prepared by Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai and countersigned by the Director of Medical Education.

3. The Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai has stated that the revised administrative sanction amount works out at Rs.6,37,93,334/- and details towards tender excess and other charges are as follows:-

The Tender Award Committee in its 188th meeting on 06.09.2013 has approved the Revised Administrative Sanction proposal for a sum of Rs.6,37,93,334/- towards the construction of second floor over the existing first floor of the new multi storied building in Tamil Nadu Government Dental College and Hospital, Chennai.

5. Hence the Director of Medical Education has requested the Government to accord revised administrative sanction for a sum of Rs. 6,37,93,334/- against the original sanction of Rs. 6,00,44,000/.

6. The Government have examined the proposal of the Director of Medical Education in detail and accord revised administrative and financial sanction for a sum of Rs.6,37,93,334/- (Rupees Six Crore Thirty Seven Lakhs Ninety Three Thousand Three Hundred and Thirty Four only) towards the construction of second floor over the existing first floor of the new multi storied building in Tamil Nadu Government Dental college and Hospital, Chennai as against the original sanction of Rs.6,00,44,000/- with an instruction that, there should not be any further Revised Administrative Sanction and subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Chennai.

7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:-

“4210-Capital Outlay on Medical and Public Health – 01- Urban Health Services – 110 – Hospital and Dispensaries (Including Pharmacy) – Schemes in the Twelfth Five Year Plan – II State Plan – JA Buildings – 16 Major Works” (D.P.C 4210-01-110-JA-1602).

8. The expenditure sanctioned in para 6 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the Contingency Fund will be issued by the Finance (BG.I) Department. The Director of Medical Education shall apply for sanction of advance from Contingency Fund for the required amount in the prescribed format along with a copy of this order to Finance (BG.I) Department. The Director of Medical Education shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-2015 to Finance Department at the appropriate time without fail.


