ORDER:

In the Government Order first read above, a sum of Rs. 17,30,11,459/- has been sanctioned for the purchase of equipment for the New Government Medical College and Hospital at Sivagangai in three phases as indicated below:-

I Phase	Rs. 10,14,38,400	To meet immediate setting up of Hospital and College for getting Letter of Indent/Letter of Permission
II Phase	Rs. 5,00,00,000	Before applying for 1st renewal of permission
III Phase	Rs. 2,15,73,059	Before applying for 2nd renewal of permission

Out of the above sanctioned amount of Rs.17,30,11,459/-, a sum of Rs.10,14,38,400/- has been released during 2011-2012. The amount has been transferred to the Personal Deposit Account of the Tamil Nadu Medical Services Corporation Limited by the Director of Medical Education during 2012.

2. The Director of Medical Education has now requested to sanction a sum of Rs. 5,00,00,000/- (Rupees five crore only) as additional sanction for the year 2013-14 since the first renewal for admission of second batch of M.B.B.S. candidates has been applied.

3. The Government have examined the proposal of the Director of Medical Education in para 2 above and accord necessary Financial Sanction for a sum of Rs. 5,00,00,000/- (Rupees five crore only) towards purchase of equipments to New Government Medical College and Hospital at Sivagangai for the second phase.

4. The expenditure sanctioned in para 3 above shall be debited to the head of account:

"2210 Medical and Public Health – 05 Medical Education, Training and Research – 105 Allopathy – Schemes in the Twelfth Five Year Plan - II State Plan JA Improvements to Medical Colleges – 19 Machinery and Equipments – 01 – Purchase

(DPC 2210-05-105-JA-1916)"

5. Necessary funds will be provided in the Revised Estimate/Final Modified Appropriation 2013-2014. Pending provision of such funds, the Director of Medical Education is authorised to draw and disburse the amount sanctioned in para – 3 above. However, this expenditure will be brought to the notice of the legislature by specific inclusion in the supplementary Estimate 2013-2014. The Director of Medical Education is directed to include this item of expenditure. While sending the proposal for Revised Estimate/ Final Modified Appropriation 2013-14 and send necessary draft explanatory notes for inclusion of expenditure in the supplementary Estimates to the Government in Finance Department without fail.

6. The Director of Medical Education is authorised to draw and deposit the amount sanctioned in para 3 above to the Personal Deposit account of the Tamil Nadu Medical Services Corporation Limited, Chennai by means of the Cheque/ Demand Draft in favour of Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited.

7. The Director of Medical Education is informed that the amount shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited:-

"K Deposit and Advances (b) Deposits not bearing Interest – 8443 00 Civil Deposits – 800 Other Deposits – CE Deposits of Tamil Nadu Medical Services Corporation Limited. (DPC 8443 -00 -800 – CE – 00 OH (Receipts)"
