### ORDER:

The Commissioner of Indian Medicine and Homoeopathy in his letter second read above has sent draft Prospectus, Application form and notification for admission to all the five Under Graduate Degree Courses under Indian System of Medicine and Homoeopathy viz., BSMS / BAMS / BNYS / BUMS and BHMS for 2013-2014 session to both Government and self Financing Colleges.

2. The Commissioner of Indian Medicine and Homoeopathy has also requested orders of the Government on certain issues relating to Selection / Admission of candidates to the above Under Graduate Courses.

3. The Government have examined the proposal of the Commissioner of Indian Medicine and Homoeopathy and decided to accept it.

4. The Government accordingly approve the prospectus application form and notification for admission of students to BSMS / BAMS / BNYS / BUMS / BHMS Courses for 2013 - 2014 session in the prospectus for 2013-2014.

5. The Commissioner of Indian Medicine and Homoeopathy is permitted to adopt the same procedure for the selection of candidates during 2013-2014 session as was done in the academic year 2012-2013 through counselling as follows:-

- (a) To arrive the General merit list for all the Indian System of Medicine and Homoeopathy Degree Courses viz., BSMS / BAMS / BNYS / BUMS / BHMS.

(b) To conduct the counselling for the spot selection for each of Degree Courses directly without arriving separate selection / waiting list for each course.

(c) to allot colleges to the candidates as per their merit of the marks and their option.

6. The Government also approve the minimum eligibility marks applicable to the previous year i.e., 2012-2013 in respect of the OC, BC, BCM, MBC and Scheduled Caste, Scheduled Caste (Arunthathiyar) Scheduled Tribe Categories for admission in Indian System of Medicine Medical Courses viz., BSMS / BAMS / BNYS / BHMS for the year 2013-2014.

7. The Rule of Reservation is being followed for all courses namely BSMS / BAMS / BNYS / BHMS. In case of BUMS no candidates become available existing from BC (Muslim) Community so far. Hence, the seats reserved for BC, MBC / DC, SC, SC (Arunthathiyars), ST could not be filled up in case of BUMS course. Therefore, permission is also accorded that any unfilled BC seats would be filled only by BC Muslims and any MBC / DNC, SC, SC(Arunthathiyars) / ST seat unfilled by thrown open to a OC (i.e. both BC and non BC Muslims), If no BC, MBC / DC, SC, SC (Arunthathiyars) candidates is available.

8. The Government to adopt the Rule of Reservation as follows:-

Open Competition	31%
Backward Community	26.50%
Backward Community (Muslim)	3.50%
Most Backward / Denotified Community	20%
Scheduled castes Scheduled Caste (Arunthathiyar) (16% of seats out of 18% quota earmarked to SC's on preferential basis)	18%
Scheduled Tribe	1%

9. The Commissioner of Indian Medicine and Homoeopathy is permitted to implement horizontal wise reservation as laid down in G.O (Ms) No.198, Higher Education Department, dated 31.05.2010 for special category.

10. The prospectus, application forms and notifications etc, duly approved by Government will be sent to Commissioner of Indian Medicine and Homoeopathy separately.
