ORDER:

In the Government Order first read above, sanction was accorded for a sum of Rs.138.77 lakh towards rebate on sale of Khadi (adhoc advance amount of Rs.100.00 lakh for the year 2009-2010 and the balance amount of Rs.38.77 lakh for the year 2007-2008) to the Tamil Nadu Khadi and Village Industries Board for the year 2009-2010.

2. The Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board in his letter third read above has stated that, the Board has already incurred Rs.160.28 lakhs upto 2009-2010 towards rebate on sale of Khadi cloth and the anticipated expenditure of Rs.200.00 lakhs is expected to be incurred during the current year i.e. 2010-2011. As regards 2010-2011, the Board has targeted to sell Khadi cloth for Rs.21.00 crores, and the anticipated rebate works out to Rs.4.20 crore.

3. The Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board has, therefore requested the Government to sanction a sum of Rs.1.00 crore as adhoc advance towards rebate on sale of Khadi cloth to the

Tamil Nadu Khadi and Village Industries Board in anticipation of audit certificate to achieve the target for the year 2010-2011.

4. The Government, after careful examination, accept the request of the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board and sanction a sum of Rs.1.00 crore (Rupees One crore only) as adhoc advance towards rebate on sale of Khadi to the Tamil Nadu Khadi and Village Industries Board for the year 2010-2011.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account.
