From the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board, Letter No.21494/C4/2009, **ORDER:** dated 18.11.2009

Handmade Paper Unit at Pidagam in Villupuram District is producing Handmade Paper using the old method. Hence, the production is very low and only low grade variety paper is produced upto 500 kgs per month. At present, Tamil Nadu Khadi and Village Industries Board is getting orders from Jail Department for the supply of 6.00 lakhs raw pads (Size 9 x 13.5) per year, the value of which works out to Rs.24.00 lakhs. With the available machinery, the Khadi and Village Industries Board is able to supply 2.25 lakhs raw pads only.

2. In the letter read above, the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board has proposed to sanction a sum of Rs.15.00 lakh under Part-II Scheme 2010-2011, for modernisation of the Handmade Paper Unit at Pidagam in Villupuram District.

3. In this, the Tamil Nadu Khadi and Village Industries Board has requested the following machinery and equipment are necessary for the modernization of Handmade Paper Unit, Pidagam, Villupuram District:-

1.Cylinder Mould	42" X 30"	1 No.
2.Agitater	7ft. depth dia 7 ft. X 7	1 No.
3.Pulp Pump Size with base Plate	3" X 2 ½	2 Nos.
4. Motor with Electrical Items		
5. Civil construction work		

By using the Cylinder mould machine the monthly production capacity can be increased by 3.5 – 4.00 lakh additionally. Moreover, additional employment can be provided to 25 workers.

4. The Government, after careful consideration, accept the proposal of Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board and accordingly sanction a sum of Rs.15.00 lakh (Rupees Fifteen Lakh only) towards modernisation of Handmade Paper Unit, Pidagam under Part-II Scheme for the year 2010-2011.

5. The amount sanctioned in para 4 above shall be debited to:-
