## ORDER:

The Tamil Nadu Khadi and Village Industries Board is producing various items of soaps in Soap Units and are supplied through sales outlets in the District offices. The detergent soap is also marketed through Public Distribution shops. The existing Machineries in the Soap Units, Sevvapet, Perumalmalai and Panruti are more than 20 years old. The Board could not be able to produce the required output from these machineries as the capacity is low and the manpower is wasted. To increase the production, and fulfil the indents received from Government Departments, it is necessary to purchase the following machineries to the above Soap Units immediately so as to enable the Board to give employment to the workers continuously:-

1.	Sigma Mixer Machine 50 to 65 Kgs. per batch (i.e.) 100 to 125 Kg. per hour each) Rs.98,000 x 3	Rs.2,94,000/-
2.	Plodder type simplex (Detergent Bar) extruding 150 Kg. per hour (each) Rs.1,15,000 x 3	Rs.3,45,000/-
3.	Roll marking attachment (each) Rs.8,000 x 3	Rs.24,000/-
4.	Hand operated cake cutting machine (each) Rs.22,000 x 3	Rs.66,000/-
5.	Die set 6 sets (each 2 sets) Rs.24,000 x 3	Rs.72,000/-

6.	Electrification, erection and commissioning transportation/ taxes etc.,(each) Rs.1,00,000 x 3	Rs.3,00,000/-
	Total	Rs.11,01,000/-

2. In the letter read above, the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board has requested the Government to sanction a sum of Rs.11.00 lakh under Part-II Scheme for the year 2013-2014, for Purchase of Machineries for 3 Detergent Soap Units.

3. The Government, after careful consideration, accept the proposal of the Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board and accordingly sanction a sum of Rs.11.00 lakh (Rupees Eleven lakh only) under Part-II Scheme for the year 2013-2014, for Purchase of Machineries for Sevvapet, Perumalmalai and Panruti Detergent Soap Units.

4. The amount sanctioned in Para 3 above shall be debited to:-
