ORDER

In the Government Orders first to third read above, orders were issued, sanctioning a sum of Rs.1752.06 lakhs from the available Budget Provision to meet out the expenditure for salary and pension to the employees and pensioners of Tamil Nadu Khadi and Village Industries Board.

The Chief Executive Officer, Tamil Nadu Khadi and Village Industries Board, in the letter fourth read above, has requested the Government to sanction a sum of Rs.1651.38 lakhs towards Net Cost Grant based on the Budget Provision 2013-2014 by relaxing Quarterly Control Appropriation so as to enable the Board to meet out the salary and pension for the months July, 2013 to September, 2013.

The Government, after careful examination, sanction a sum of Rs.1651.38 lakhs (Rupees Sixteen crores fifty one lakhs and thirty eight thousands only) towards Net Cost Grant for the payment of salary and pension for the months July, 2013 to September, 2013 to the employees and pensioners of Tamil Nadu Khadi and Village Industries Board from the Budget Provision 2013-2014, by relaxing the Instruction on Quarterly Control of Appropriation system communicated in the G.O.Ms.No.102, Finance (BG-I) Department, dated 29.03.2013.
