ORDER:-

Mahatma Gandhi Bunkar Bima Yojana for Handloom Weavers is being implemented from the year 2004-2005. The annual premium per weaver/Ancillary worker under the Scheme is Rs.330/-.The premium structure is as indicated below:-

Government of India contribution	150/-
State Government contribution	80/-
Life Insurance Corporation of India contribution	100/-

2) The Director of Handlooms and Textiles in his letter second read above has stated that, the Mahatma Gandhi Bunkar Bima Yojana Policies are renewable every year and continuation of coverage is ensured only on payment of premium on the due date of renewal every year. The existing policy period 2012 - 2013 expires on 1.10.2013 and these policies have to be renewed with effect from 02.10.2013. The tentative target for the policy year 2013-2014 under Mahatma Gandhi Bunkar Bima Yojana, in respect of Tamil Nadu State the Government of India have fixed as 2,70,000 policies.

3) The Director of Handlooms and Textiles has, therefore, requested the Government to sanction a sum of Rs.1,88,00,720/- towards the State Share of premium to Life Insurance Corporation on behalf of 2,35,009 existing Handloom workers / Ancillary workers under Mahatma Gandhi Bunker Bima Yojana for the year 2013-2014.

4) The Government after careful consideration, accept the request of the Director of Handlooms and Textiles and sanction a sum of Rs.1,88,00,720/- (Rupees One Crore Eighty-eight Lakhs Seven Hundred and Twenty only) towards the State Share of premium to Life Insurance Corporation on behalf of 2,35,009 existing Handloom workers / Ancillary workers under Mahatma Gandhi Bunker Bima Yojana for the year 2013-2014 at the rate of Rs.80/- per weavers per annum.

5) The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

" 2851 00 Village and Small Industries - 103 - Handloom Industries - Schemes in the Twelfth Five Year Plan - II State Plan - KN. Payment of premium for Tamil Nadu Co-operative Handloom Weavers under Bunkar Bima Yojana Scheme - 10 Contributions - 02 Insurance Premium"

6) The Director of Handlooms and Textiles is authorized to draw the amount sanctioned in para 4 above and to pay the same to the Life Insurance Corporation of India on behalf of Handloom Weavers / Ancillary Workers under the Mahatma Gandhi Bunkar Bima Yojana for the year 2013 - 2014 and he is responsible for the proper implementation of the Scheme.
