ORDER:

In the Government Order first read above, the Government have issued orders introducing various incentives and concessions including State Capital Subsidy to eligible micro, small and medium manufacturing enterprises in the State based on the Micro, Small and Medium Industries Policy 2008. State Capital Subsidy is given to the following enterprises:-

- (1) Micro Manufacturing Enterprises established anywhere in the State.
- (2) Micro, Small and Medium Manufacturing enterprises established in industrially backward areas and agro based industries set up in 385 blocks in the State.
- (3) Thrust sector industries set up anywhere in the State. (Special Capital Subsidy)

2. In the Government Order second read above, the Government have sanctioned an amount of Rs.15.00 crores (Rupees Fifteen crores only) towards disbursement of state capital subsidy to the micro, small and medium manufacturing enterprises, thrust

sector industries and agro based enterprises for the year 2010-11. An amount of Rs.30,638/- has been sanctioned in the Government order third read above towards reimbursement of the amount remitted by Thiru M.Selvarajan, Joint Director of Industries and Commerce (Retired).

3. The Industries Commissioner and Director of Industries and Commerce in his letter second read above, has requested the Government to sanction a sum of Rs.20 crores towards state capital subsidy to eligible micro, small and medium manufacturing enterprises, thrust sector enterprises and agro based enterprises as second instalment for the year 2010-11.

4. The Government, after careful examination, accept the proposal of the Industries Commissioner and Director of Industries and Commerce in para 3 above and sanction a sum of Rs.9,99,69,362/- crores (Rupees Nine crores ninty nine lakhs sixty nine thousand three hundred and sixty two only) towards disbursement of state capital subsidy to the micro, small and medium manufacturing enterprises, thrust sector enterprises and agro based enterprises for the year 2010-11.

5. The amount sanctioned in para 4 above shall be debited to the following head of account:-

“2851-00-Village and Small Industries – 102 – Small Scale Industries – Schemes in the Eleventh Five Year Plan-II State Plan – LZ Capital Subsidy to Micro, Small, Medium and Agro-based Industries – 11 Subsidies – 01 Individual Based Subsidy”.

6. The Industries Commissioner and Director of Industries and Commerce is authorized to draw the amount sanctioned in para 4 above and disburse to the General Managers, District Industries Centres / Regional Joint Director, Chennai. The Industries Commissioner and Director of Industries and Commerce is instructed to send the utilization certificate to the Government.
