ORDER :

In the G.O. first read above, orders were issued introducing a scheme of awarding medals to the Government employees who attend office without being late during a year even for a single day either with permission or without permission in order to encourage Government servants to attend office in time. The above scheme is applicable to the categories of Typist, Personal Clerk, Assistant, Assistant Section Officer and Section Officer in the Departments of Secretariat and Typist, Steno-Typist, Junior Assistant, Assistant and Superintendent in the office of the Heads of Department and District Collectors. In the G.O. second read above, orders were issued for the award of Indira Vikas Patras to the value of Rs.100/- instead of medals, to the eligible persons. It was further clarified that the above orders would be applicable to the employees who had availed themselves of any kind of leave not exceeding 15 days in a year. Accordingly, in the G.O. 3rd, 4th and 5th read above, orders were issued for the award of Indira Vikas Patras to the eligible Government servants who attended to office without being late either with permission or without permission in the years 1989-90, 1990-91, and 1991-92.

2. The purpose of the scheme is to ensure that those who attend to clerical work are prompt in their attendance. The Government have reviewed the working of the Scheme in consultation with certain Heads of Department. The number of persons

who became eligible for award under the Scheme during the period from 1989-90 to 1991-92 are found to be very few.

3. The Government after careful consideration, have therefore decided to discontinue the above scheme. They accordingly direct that the scheme referred to in para 1 above be discontinued with immediate effect.
