#### **ORDER:**

The Government appoint Thiru N.S. Nandakumar as Government's Senior Standing Counsel, Thiru T.R. Kumarasingh as Government's Standing Counsel and Thiru C. Manogharan as Government Additional Standing Counsel for appearance before the Tamil Nadu Administrative Tribunal for attending to all items of Works connected therewith.

2. Their duties shall be in accordance with the standing orders Part-I Law Officers. High Court, Chennai as issued in G.O.Ms.No. 607, Public (Estt.I) Department, dated 28.3.81 as amended from time to time. The Senior Standing Counsel will be in the grade of Government Pleader and Additional Standing Counsel in the grade of Additional Government Pleader.

3. The Senior Standing Counsel, Tamil Nadu Administrative Tribunal shall be paid a retainer fee of Rs.2500/- (Rupees Two thousand five hundred only) per month. The Standing Counsel and Additional Standing Counsel shall be paid a retainer fee of Rs.2000/- (Rupees Two thousand only) per month. In addition to that they are eligible for remuneration for drafting/appearance and etc. before the Tamil Nadu Administrative Tribunal as indicated in the Annexure to this order.

4. The following Notification shall be published in the Tamil Nadu Government Gazetted:-

#### **NOTIFICATION-I**

Thiru N.S.Nandakumar is appointed as Government Senior Standing Counsel in the grade of Government Pleader, High Court, Chennai for appearance before Tamil Nadu Administrative Tribunal.

#### **NOTIFICATION-II**

Thiru T.R.K. Kumarasingh is appointed as Government's Standing Counsel in the grade of Additional Government Pleader, High Court, Chennai for appearance before the Tamil Nadu Administrative Tribunal.

### NOTIFICATION-III

Thiru C. Manogharan is appointed as Government's Additional Standing Counsel in the grade of Additional Government Pleader, High Court, Chennai for appearance before the Tamil Nadu Administrative Tribunal.

**(SINGLE MEMBER TRIBUNAL OR BENCH CONSISTING OF CHAIRMAN/VICE-CHAIRMAN AND JUDICIAL/ADMINISTRATIVE MEMBER)**

**ORIGINAL APPLICATION/TRANSFERRED APPLICATION**

1. 1. Fully contested case  
Main case – Rs.250/-  
For a batch of cases, Rs.250/- for the main case, Rs.50/- per connected case subject to a ceiling of Rs.2500/-
2. 2. Disposed of at the stage of admission with argument Rs.100/- for the main case. For a batch of cases Rs.50/- per connected case subject to a ceiling of Rs.5000/-
3. 3. Disposed of at the stage of admission without argument:-

Rs.50/- for the main case. For a batch of cases, Rs.25/- per connected case subject to a ceiling of Rs.2500/-

4. Disposed of following judgement in a previous case or which has become infructuous or withdrawn.

Rs.75/- for the main case. For a batch of cases Rs.50/- per connected case subject to a ceiling of Rs.2500/-

In respect of Items 1 and 4 above, if no counter affidavit was filed in the Tribunal, the Law officer will be allowed half of the fee prescribed in item 1 or item 4, as the case may be. If the counter was prepared but not filed in the Tribunal, the Law Officer shall be allowed half of the fee payable for preparation and filing of the counter.

1. For each petition  
Fully contested case disposed of separately Rs.100/-

2. Petition disposed of: a batch

1. (a) for the main application – Rs.100/-
- (b) for each connected application – Rs.25/- subject to a ceiling of Rs.250/-

CONTEMPT APPLICATION

Arising from the separate or common judgement or each application Rs.250/-

II. DRAFTING

FOR ORIGINAL APPLICATION/TRANSFERRED APPLICATION/CONTEMPT APPLICATION

Rs.150/- for the main case. If it is a common affidavit or counter for batch of cases then Rs.75/- for every subsequent case subject to a ceiling of Rs.2500/-

FOR REVIEW APPLICATION/MISCELLANEOUS APPLICATION

Rs.150/- for the main case, Rs.75/- for every subsequent case subject to a ceiling of Rs.2500/- in batch cases.

The Government Advocates shall be paid 40% of the remuneration payable to the Law Officers for assisting them.
