ORDER:

The Director, Anna Institute of Management has stated that there is a huge demand from candidates all over the State for joining the coaching provided at the All India Civil Services Coaching Centre, that the residential facilities at the Housing Board accommodation at Anna Nagar cannot take more numbers and that many of the candidates who prepare for the examination are either employed or studying during the period of preparation for the Civil Service Examination and are not in a position to attend the residential coaching programme. With a view to make it more convenient for non-residential candidates also to take up the Entrance Test and to provide coaching to a larger number of selected candidates, keeping in mind the constraints imposed by the restricted hostel availability, tutor-timings and financial constraints, the Director, Anna Institute of Management has proposed the following:-

1. Conduct of entry test for Preliminary coaching at three additional centers, namely, Thanjavur, Dharmapuri and Sivagangai.
2. Conduct of non-residential training programme for 2004, Preliminary Examination from December,2003 to May,2004, for 100 candidates in addition to the 200 who will continue to be imparted residential coaching free of cost.
3. Charging a nominal fee of Rs.1,000/- (Rupees one thousand only) towards General Studies and Rs.500/- (Rupees five hundred only) towards Optional Subject for coaching of these 100 additional candidates to cover the additional costs involved in extra teaching hours and administrative expenses.

2. The Government after careful examination, have decided to accept the proposal of the Director of Anna Institute of Management. Accordingly, they direct the Director General of Training, Anna Institute of Management:-

1. To permit the All India Civil Services Coaching Centre to conduct the Entrance Test for the 2004 Preliminary Examination coaching, at three additional centers, namely, Thanjavur, Dharmapuri and Sivagangai;
 2. To permit the Coaching Centre to conduct evening classes (to be conducted from December, 2003 to May, 2004) on a non-residential basis for the Union Public Service Commission Preliminary Examination 2004, for another 100 candidates to be selected from the same Entrance Test and interview ; and
 3. To charge a nominal fees of Rs.1,000/- (Rupees one thousand only) towards General Studies coaching and Rs.500/- (Rupees five hundred only) towards Optional Subject coaching, from these 100 candidates selected for non-residential coaching.
- 3.The Director, Anna Institute of Management is authorised to collect the fees and credit the same into the following Head of Account:-

"0070. Other Administrative Services – 60. Other Services – 800 – Other receipts CW – fees collected from the general candidates for imparting training to Civil Services Examination – 01. Tuition fees".
