#### **ORDER:**

In the Government order first read above, all the District Collectors and Heads of Departments and the certificate issuing authorities under their control were requested to adopt the list of Scheduled Castes and Scheduled Tribes contained in the Scheduled Castes and Scheduled Tribes Orders (Amendment) Act, 1976 (Central Act 108 of 1976) and the Constitution (Scheduled Castes) Orders (Amendment) Act, 1990 (Central Act 15 of 1990) strictly, since it was brought to the notice that certificate issuing authorities were still not adopting the revised lists and correct names of Scheduled Caste and Scheduled Tribe while issuing the Community Certificate to eligible and genuine persons, belonging to Scheduled Caste and Scheduled Tribe.

2. Consequent to the above orders, the following Notification will be published in the Tamil Nadu Government Gazette:-

#### **NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to Part I - Preliminary of the Tamil Nadu State and Subordinate Services Rules (Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 3rd June 1990.

**AMENDMENT**

In the said Rules, in Part I - Preliminary, in rule 2, in clause (16), for the Explanation, the following Explanation shall be substituted, namely:-

"Explanation.- No person who professes a religion different from Hinduism or Sikhism or Buddhism shall be deemed to be a member of a Scheduled Caste:

Provided that nothing contained in this Explanation shall adversely affect the notifications issued and selections or appointments made during the period on and from the 3rd June 1990 to the 1st August 2008."
