ORDER:

In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Business Rules, 1978:-

AMENDMENTS

In the said Rules, in the "FIRST SCHEDULE",

- (1) under the heading "HIGHWAYS DEPARTMENT",-
 - (a) under the sub-heading "State Subjects", the following entries shall be omitted, namely:-

"Ferries, Inland Waterways and traffic thereon, as regards all types of boats or vessels either mechanically propelled or by manual device except in respect of waterways declared by Parliament by law to be National Waterways, Liveries and Clothing.

Operation and Maintenance of Buckingham Canal".;

(b) under the sub-heading "Concurrent Subjects",

(i) the entry "Inland Water Transport." shall be omitted;

(ii) the following entry shall be omitted, namely:-

"Shipping and navigation on inland waterways as regards mechanically propelled vessels, and the rule of the road on such waterways and the carriage of passengers and goods on inland waterways except in regard to those waterways declared by Parliament by law to be National Waterways";

(2) under the heading "PUBLIC WORKS DEPARTMENT", under the sub-heading "State Subjects", for the entry "Canals except operation and maintenance of Buckingham Canal", the following entry shall be substituted, namely:-

"Canals including operation and maintenance of Buckingham Canal.";

(3) under the heading "TRANSPORT DEPARTMENT",-

(a) under the sub-heading "State Subjects," after the entry 'Criminal Appeals', the following entry shall be inserted, namely:-

"Ferries, Inland Waterways and traffic thereon, as regards all types of boats or vessels either mechanically propelled or by manual device except in respect of waterways declared by Parliament by law to be National Waterways, Liveries and Clothing.";

(b) under the sub-heading "Concurrent Subjects", for the entry, the following entries shall be substituted, namely:-

"Inland Water Transport.

Rail Transport including land acquisition but excluding matters pertaining to over bridges and subways

Shipping and navigation on inland waterways as regards mechanically propelled vessels and the rule of the road on such waterways and the carriage of passengers and goods on inland waterways except in regard to those waterways declared by Parliament by law to be National Waterways."
