

In the letter second cited, based on the above proposal, the Secretary, Tamil Nadu Public Service Commission was requested to obtain the views of the Commission.

In the letter third cited, the Secretary, Tamil Nadu Public Service Commission has informed that the Equivalence Committee in its meeting held on 10.08.2009 has resolved not to recommend to consider the first year M.Ed., Technology (Semester) Course offered by Madurai Kamaraj University as equivalent to B.Ed., degree course for the purpose of employment in Public Services.

The Government after careful examination of the recommendation of the Equivalence Committee has decided to accept it and accordingly directs that the first year M.Ed., Technology (Semester) Course offered by Madurai Kamaraj University cannot be considered as equivalent to B.Ed., degree course for the purpose of employment in Public Services.
