The following Notification will be published in the Tamil Nadu Government Gazette:-

**NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309, read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules.

2. The amendment hereby made shall be deemed to have come into force on the 11<sup>th</sup> August 2008.

**AMENDMENT.**

In the said Rules, in rule 110, in sub-rule (b), after clause (xx), the following clause shall be added, namely:-

“(xxi) The Director General of Police shall be competent to sanction the deputation of Officers in the rank of Deputy Superintendents of Police, to the various State owned Corporations or Undertakings on Foreign Service terms subject to the norms or guidelines laid down by the Government in this regard, from time to time.”
