The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by Article 318 and the Proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume-I of the Tamil Nadu Service Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 27th day of February 1998.

AMENDMENT

In the said Regulations, in ANNEXURE I-A, under the heading "B - SUBORDINATE SERVICES", in item 3, after sub-item (Liii), the following sub-item shall be added, namely:-

" (Liv) All the posts in the Tamil Nadu Geology and Mining Subordinate Service, which carry a starting pay higher than Rs.4,000/- per month".
