ORDER:

In the Government Order 6th read above, Government have directed that the shortfall vacancies of Scheduled Castes / Scheduled Tribes in the lowest level of posts in each Group A,B,C & D shall be filled up through the recruiting agencies by direct recruitment for which General Rule 22 of Tamil Nadu State and Subordinate Services be amended suitably.

2. Consequent to the above order and the orders issued in the Government Orders and letter 1st to 5th read above, the following Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the General Rules in Part II of the Tamil Nadu State and Subordinate Services Rules (Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall come into force on the 14th September 2007.

AMENDMENT

In the said Rules, in rule 22, after clause (f), the following clause shall be added, namely :-

“(g) Notwithstanding anything contained in this rule, in order to restore the representation of Scheduled Castes & Scheduled Tribes in a service, where their representation is less than 18 percent and 1 percent respectively, each department shall furnish the shortfall vacancies of Scheduled Castes & Scheduled Tribes in the lowest level of posts in each of the Groups A,B,C and D, besides the posts of Junior Assistant, Typist and Steno-Typist - Grade III in the Tamil Nadu Ministerial Service and the Tamil Nadu Judicial Ministerial Service, to the Government and the Government in turn shall inform the same to the recruiting agencies for notifying the vacancies for direct recruitment as a one time measure :

Provided that reservation for women and physically handicapped shall not apply to the said recruitment.”.
