The following Notification will be published in the Tamil Nadu Government Gazette :-

### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Personnel and Administrative Reforms Department Notification No.SRO A-72(b) / 2000, dated the 11<sup>th</sup> September 2000, published at pages 1 to 3 of Part III- Section I (a) of the Tamil Nadu State Government Gazette Extraordinary, dated the 11<sup>th</sup> September 2000.

**2. The amendment hereby made shall be deemed to have come into force on the 28th March 1989.**

**AMENDMENT**

In the said Notification, in the preamble, the following paragraph shall be added, namely :-

"2. The amendment (1) (a)(i) hereby made shall be deemed to have come into force in respect of "Backward Classes and Most Backward Classes / Denotified Communities" on the 28<sup>th</sup> March 1989 and in respect of "General Turn" on the 30<sup>th</sup> January 1996."


