ORDER:

In the Government Order 1st read above orders have been issued to fill up vacancies temporarily in the post of Typist and Steno -Typist grade-III in the Tamil Nadu Ministerial Service/ Tamil Nadu Judicial Ministerial Service through the Commissioner of Technical Education by formulating a scheme. In the Government Order 2nd read above necessary rules of procedure have been issued in which, among others the Collectors were authorised to get the list of eligible candidates from the District Employment Exchange concerned in the ratio of 1:2 for the said temporary recruitment. In the Government Order 3rd read above the Judicial Department was exempted and the appointing authorities in that Department were permitted to make temporary appointment in this regard through Employment Exchange as laid down in rule 16 of the Special Rules for the Tamil Nadu Ministerial Service.

2. In the Government Order 4th read above the Government in the Labour and Employment Department have issued orders among others that for filling up of any vacancy in any employment in Government Departments, Local Bodies (Urban and Rural), Co-operative institutions, Public Sector Undertakings, all Government aided Educational Institutions and Government aided Engineering

Colleges and Polytechnics etc. Employment Exchanges should sponsor candidates to the employers in the ratio of 1:1 (one: one) as per seniority of registrants, who are in the live register.

3. The following amendment is therefore issued to the orders issued in G.O.(Ms)No.205, Personnel & Administrative Reforms(P) Department, dated 9.11.2006.
