ORDER:

In the Govt. Order first read above, under sub-section (1) of Section 15 of the Right to Information Act, 2005, the Government have constituted the Tamil Nadu Information Commission. In the Government Order 2nd read above, Thiru S.Ramakrishnan, I.A.S., (Retd.) has been appointed as State Chief Information Commissioner and the above appointment has also been published in the Tamil Nadu Government Gazette Extraordinary dated 12.01.2006. In the Government Order 3rd read above, orders have been issued that Thiru S. Ramakrishnan, I.A.S., (Retd.) State Chief Information Commissioner, Tamil Nadu Information Commission ceases to hold office on attaining the age of 65 years on the afternoon of 30.08.2010 as provided in sub-section (1) of section 16 of the Right to Information Act, 2005.

2. The Governor of Tamil Nadu has decided to appoint Thiru K.S.Sripathi, I.A.S. (Retd.) as State Chief Information Commissioner in the Tamil Nadu Information Commission.

3. The following Notification shall be published in the Tamil Nadu Government Gazette Extraordinary, dated 1st day (Wednesday) of September 2010.

NOTIFICATION

In exercise of the powers conferred by sub-section (3) of section 15 of the Right to Information Act, 2005 (Central Act 22 of 2005), the Governor of Tamil Nadu hereby appoints Thiru K.S.Sripathi, I.A.S. (Retired.) as State Chief Information Commissioner in the Tamil Nadu Information Commission.

4. The State Chief Information Commissioner shall hold office for a term of five years from the date on which he enters upon his office or the date on which he attains the age of sixty-five years, whichever is earlier.
