**ORDER:**

In the Government Order read above, among others, rule 8 (v) ( c) of the Tamil Nadu Civil Services (Discipline and Appeal) Rules have been deleted. Consequent to this, necessary amendment to rules 23(1) and 36(1) have not been carried over. To rectify the above, it is decided to issue necessary amendments to the said rules.

2. Further, to amplify the method of appointments mentioned in Rule 15(a) of Tamil Nadu Civil Services (Discipline and Appeal) Rule, viz. "appointment by promotion or transfer" it is decided to issue necessary amendments to the said rule.

3. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette :-

**NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Civil Services (Discipline and Appeal) Rules ( in Volume I of the Tamil Nadu Services Manual, 1987) :-

2. The amendments hereby, made shall come into force on the 28<sup>th</sup> September of 2011.

**AMENDMENTS.**

In the said Rules, -

- (1) in rule 15 in sub-rule (a), for the expression "promotion or transfer", the expression "promotion or transfer or recruitment by transfer" shall be substituted;

(2) in rule 23, in the proviso to sub-rule (1),-

(a) in clause (i), for the expression "clauses (iv),(v)(c)", the expression "clauses (iv), (v)" shall be substituted;

(b) in clauses (ii), for the expression " clauses (iv),(v)(c)", the expression " clauses (iv),(v)" shall be substituted;

(3) in rule 36, in the first proviso to sub-rule (1), for the expression "clauses (iv), (v) (c)", the expression " clauses (iv), (v)" shall be substituted.
