ORDER:

As per the second proviso to Rule 10(a)(i)(1) of the General Rules for Tamil Nadu State and Subordinate Services, the reserve list of successful candidates shall be in force until the regular list of successful candidates is drawn up subsequently and that candidates shall be allotted from such reserve list for the vacancies in the place of those who have not joined duty. In its letter dated 6.8.98, the Tamil Nadu Public Service Commission has stated that the Commission is selecting candidates from the Reserve list against the vacancies caused due to non-joining duty of the candidate for regular appointment only and that a candidate selected from the Reserve list in the place of a candidate who failed to join duty or his provisional selection is cancelled for any reason, is entitled for regular appointment since the vacancy caused is a regular appointment. Stating the above, the Commission has proposed that such candidates so selected shall be placed below all the candidates in the Regular List in the same order in which the vacancies have arisen as illustrated below:-

In a recruitment to a post in a Service, 100 candidates have been selected. The selection of candidates against 6th turn (GT), 14th Turn (SC), 21st turn (MBC/DC), 35th turn (GT), 46th turn (BC), 59th turn (BC), 64th turn (SC), 74th turn (GT), 84th turn (MBC/DC), 91st turn (GT), have been cancelled for failure to join duty or provisional selection has been cancelled for any reason. The candidates selected from the respective category in the Reserve List based on ranking shall be placed below all the candidates in the Regular List in the following order:-

- 100 A - General Turn
- 100 B - Scheduled Castes
- 100 C - Most Backward Classes/Denotified Community
- 100 D - General Turn
- 100 E - Backward Classes
- 100 F - Backward Classes
- 100 G - Scheduled Castes
- 100 H - General Turn
- 100 I - Most Backward Classes /Denotified Community
- 100 J - General Turn

2. The Secretary, Tamil Nadu Public Service Commission has also requested that the Commission selected candidates from the categorywise reserve list and approved on 20.10.98 for the post of Assistant Engineer (RD) and also for the subsequent selections, pending issue of amendments to the General Rule 22(d). The Tamil Nadu Public Service Commission has also requested that the amendments may be given retrospective effect from 20.10.98, in order to validate the Commission's selections made from the reserve list.

3. The Government have examined the proposal carefully and have decided to accept it. However, the candidates selected and appointed from the reserve list for temporary vacancies shall not be continued for a period of more than one year from the date of their temporary appointment.

4. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu State and Subordinate Services Rules (in Volume I of the Tamil Nadu Services Manual, 1987).

2. (i) The amendments (1) and (2)(i) shall be deemed to have come into force on the 16th August 1982.

(ii) The amendment (2)(ii)(a) shall be deemed to have come into force on the 20th October 1998.

(iii) The amendment (2)(ii) (b) shall come into force on the 13th September 2006.

AMENDMENTS

In the said Rules, -

(1) in PART I - PRELIMINARY, in rule 2 -

(i) clause (15-A) shall be renumbered as clause (15-B);

(ii) Before clause (15-B), as so renumbered, the following clause shall be inserted, namely: -

" (15-A) Reserve List - "Reserve list " shall mean a list which is prepared so as to contain not less than 25% of the candidates of each reservation group including General Turn in the regular list and shall be in force until the regular list is drawn up subsequently. " ;

(2) in PART II - GENERAL RULES, -

(i) in rule 10, in sub-rule (a), in clause (i), in sub-clause (1), -

(a) the second proviso shall be omitted;

(b) in the third proviso for the expression "Provided also", the expression "Provided further" shall be substituted;

(ii) in rule 22, in sub-rule (d), -

(a) after the fourth proviso, the following provisos shall be added namely:-

"Provided also that when a candidate selected for appointment against a vacancy for Scheduled Castes, Scheduled Tribes, Most Backward Classes/Denotified Communities, Backward Classes or General Turn, does not join duty in the post for which he is appointed or his provisional selection for that post is cancelled for any reason, a candidate in his place shall be appointed from the respective community and in accordance with the ranking from the Reserve list:

Provided also that the candidates appointed from the Reserve list shall be placed below all the candidates appointed from the regular list in the same order in which the vacancies have arisen;" ;

(b) after the sixth proviso, as so added, the following proviso shall be added, namely:-

" Provided also that the Reserve list shall be operated even against the vacancies caused due to the fact that the candidates have joined duty but left thereafter while the Reserve list is in force."
