ORDER:

In the Government Order read above, orders have been issued to the effect that the 1% vacancy reserved in the teachings posts of School Education Department for the deaf be diverted to the blind thereby bringing the reservation for the blind in teaching posts to 2% and that the 1% of vacancy reserved for the blind in the non-teaching posts in the School Education Department be diverted to the deaf and dumb, thereby bringing the reservation for the deaf and dumb in non-teaching posts to 2%. The Government have decided to have the same method in the case of similarly placed teaching and non-teaching posts available in other departments, namely, Adi Dravidar and Tribal Welfare Department (Adi Dravidar and Tribal Welfare Schools), Social Welfare Department (Special Schools) and Backward Classes and Most Backward Classes Department (Backward Classes and Most Backward Classes Schools) and to issue amendments to the General Rules.

The following Notification will be published in the **Tamil Nadu Government Gazette.**

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the General Rules in Part II of the Tamil Nadu State and Subordinate Services Rules. (Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendments hereby made shall come into force on the 26th September 2006.

AMENDMENTS

In the said Rules, in rule 22, in clause (aa), -

- (i) in the second proviso, the following sentence shall be added at the end, namely:-

"This shall, however, be subject to the third proviso to this clause.";

- (ii) after the second proviso, the following proviso shall be inserted, namely:-

"Provided also that in the teaching posts of School Education Department, Adi Dravidar and Tribal Welfare Department, Social Welfare Department and Backward Classes and Most Backward Classes Department, other than orthopaedically physically handicapped, the reservation for the blind shall be two percent, and there shall be no reservation for the deaf. In the non-teaching posts in the above Departments, other than orthopaedically physically handicapped, the reservation for the deaf shall be two percent, and there shall be no reservation for the blind:".
