ORDER:

In the Government Order read above, Government have decided to prescribe 'a Bachelor's Degree' as the requisite educational qualification for appointment to the post of Section Officer in any department other than Law and Finance by recruitment by transfer from the category of Assistant Section officer in the Departments of Secretariat other than Law and Finance in the Tamil Nadu Secretariat Service. Since the post of Section Officer is the feeder category for the post of Under Secretary to Government, it is proposed to prescribe 'a Bachelor's Degree' as the pre-requisite educational qualification, for appointment to the post of Under Secretary to Government in the departments of Secretariat, other than Law and Finance, by promotion, from the category of Section Officer under Category-2, Class-XII of the Tamil Nadu General Service.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to Class-XII of the Special Rules for the Tamil Nadu General Service.

2.The amendment hereby made shall come into force on the 16th December 2011.

AMENDMENTS.

In the said Special Rules, in Class-XII, in the Annexure, in column (3),-

(1) against the entry "Under Secretary in any department other than in Law and Finance" in column (1) and the entry "Promotion" in column (2) thereof,-

(i) for the entry "(i) Must have rendered service for a period of not less than two years in the category of Section Officers in the Departments of Secretariat other than Law and Finance", the following entries shall be substituted, namely:-

- "(i) Must hold a Bachelor's Degree of any University recognised by the University Grants Commission for the purpose of its grant;
- (i-a) Must have rendered service for a period of not less than two years in the category of Section Officers in the Departments of Secretariat other than Law and Finance;"

(2) against the entry "Under Secretary in any department other than in Law and Finance" in column (1) and the entry "Recruitment by transfer" in column (2) thereof, for the entry "Must have had previous experience in dealing with some of the subjects with which he will deal as Under Secretary", the following entries shall be substituted, namely:-

- "(i) Must hold a Bachelor's Degree of any University recognised by the University Grants Commission for the purpose of its grant;
- (ii) Must have had previous experience in dealing with some of the subjects with which he will deal as Under Secretary;"
